Sheltered English Immersion Teacher Endorsement for initial licensure programs: Graduates of WGU teacher preparation programs will be eligible for a 5-year Provisional license in Massachusetts. Educators must obtain the Sheltered English Immersion (SEI) endorsement in order to be eligible for an Initial teaching certification. To be eligible for the Sheltered English Immersion endorsement, they must pass the [MTEL Sheltered English Immersion \(56\)](#) test.
